PUBLIC PERFORMANCE LICENSING AGREEMENT

1. License:

Criterion Pictures USA, Inc grants to Missouri Dept of Corrections (hereinafter referred to as Department) the nonexclusive right to publicly perform and exhibit certain feature films on video (Programs) within the premises of the Institutions identified on Attachments 1 and 2.

The programs may be performed or exhibited by the Department on video playback or projection equipment. Admission or viewing fees may not be charged.

2. Term:

The term of this Agreement shall commence on 5/1/16 continue in force and effect for one (1) year periods.

3. Programs:

The license hereby granted is solely for the Programs to which Criterion Pictures holds Public Performance Rights, and for which it is the authorized and licensed distributor for the film producers, studios, and distributors listed on the attached Schedule B (which may be modified as necessary from time to time, by notice from Criterion Pictures to the Department at the address set out above).

The programs may be obtained (rented, leased or purchased) by the Institution from any video retailer or public library. They must, however, be legally manufactured copies. Copies that have been dubbed from broadcast, cable, satellite, or transferred from another copy are not covered by this agreement.

4. Reports:

The Institutions agree that they will provide Criterion Pictures with a written monthly report listing each of the Program(s) exhibited and the source from which each program was acquired. The report is due within ten

(10) days of the end of each month throughout the term of this Agreement. If no Programs were exhibited during the month, the Institution is required to submit a report with a notation indication that no Programs were exhibited.

5. Services:

Throughout the Term of this Agreement, Criterion Pictures shall operate an 800 telephone number (800-565-1996 x 240), which shall be available to the Institution in order that it may obtain, if desired:

- A. Information concerning the availability of any specific title(s) within the governance of this Agreement; and/or
- B. The video classification or exhibition rating

The website for Criterion Pictures USA is www.criterionpicusa.com.

6. Fees:

The Department agrees to pay Criterion Pictures an annual fee of **\$41,237.10** for the License and Services described in this Agreement. The fee is based on **30546** inmates at a **\$1.35** each. Fees are due and payable within thirty (30) days of the signing of this agreement, and the first day of each renewal term.

7. Warrants:

Criterion Pictures represents and warrants that it has the right to license public performances of the Programs owned by the producers, studios, and distributors listed on Schedule B, and agrees to hold the Department harmless from any claims arising from or out of the exhibition of the Programs, provided that:

- A. The use has been consistent with the Agreement, and within the terms and conditions specified above; and
- B. The Department shall have given written notice of any claim to Criterion Pictures, as promptly as is reasonable possible after it becomes aware of such claim.

Violation of any of the terms and conditions of this license may subject the infringing party to civil and criminal prosecution and damages, as provided in the US Copyright Law (Public Law 94-553), and will result in immediate revocation of the license and no further exhibitions under this license will be permitted. No portion of the fee will be returned to the Department in such circumstances.

This agreement contains the entire Agreement between Criterion Pictures and the Department, and shall be legally binding upon each of them, in accordance with its terms.
