A program offered by inmates at JCCC for male, and CCC for female at risk youthful offenders. The program provides education into making positive lifestyle choices.

RESTORATIVE JUSTICE REPARATION BOARD

A twelve to eighteen month program designed for first time property crime offenders, working with community members to give each offender opportunities to repay the community for crimes they have committed. Available in Jasper County.

RECOVERY COURT

Intensive approach to dealing with offenders with substance abuse problems. The offender works with a team of specialists while learning to make positive decisions while on supervision. Available in Jasper and Barton Counties.

MENTAL HEALTH COURT

Intensive approach to dealing with offenders with mental health issues. The offender works with a team of specialists to address mental health issues and monitor medications, while learning to make positive decisions in their lives. Available in Jasper County.

DWI COURT

Intensive approach to dealing with offenders with substance abuse problems. The offender works with a team of specialists while learning to make positive decisions while on supervision. Available in Jasper County.
