









The length of sentence and institutional behavior determines the custody level. Offenders with more than eight years to serve or convicted of a dangerous felony and with more than five years to serve are C-5 (maximum security). Offenders with less than 12 months to serve and with good institutional behavior are C-1. Sex offenders who are required to complete the Missouri Sex Offender Program have a custody override of C-4. Escapes are held at C5 institutions until release.





What is of significance to the department, because of the impact upon the prison bed capacity, is the increase in new admissions that are sentenced to a prison sentence. 



The number of females released to parole has more than doubled since 1996 while the number of female offenders released on the conditional release date has been reduced since 2002.


## 7. Time Served on First Release

Time served as a percent of the sentence in the last three years has decreased from 49.1% to 46.1%. The reduction has been limited to offenders serving nonviolent and drug offenses and has been supported by a new salient factor risk assessment. The risk measure has helped the Board of Probation and Parole assess the risk of offenders re-offending when setting the presumptive release date. Offenders convicted of offenses committed after August 28, 1994 have to serve a minimum prison term, if they have committed a dangerous felony (85%) or have prior incarcerations with the Missouri Department of Corrections (40% one prior, 50% two priors and 80% three or more prior incarcerations). Time served includes jail time that is credited to an offender's sentence for incarceration prior to receipt by the Department of Corrections.


**Time Served to First Release


**Time Served to First Release


**Time Served to First Release


**Time Served to First Release


**Time Served to First Release













Authorized Releases from Supervision FY 1996-2005



**Authorized Female Releases From Supervision, FY 1996-2005**



FY 2005**




