

## District Programs

### **Anger Management Education**

Twelve week program that provides educational material to address the issues of domestic violence and anger management.

### **Intake**

Orientation program for first-time offenders. The conditions of supervision are reviewed along with information on how to successfully complete your probation or parole.

### **Offenders Offering Alternatives (OOA)**

The inmates at SECC sponsor this program for at-risk first-time offenders. This includes inmate presentations, institutional tours, and one-on-one interaction with inmates.

### **Pathway to Change (PTC)**

A cognitive restructuring program to help offenders make positive choices and changes.

### **Sex Offender Therapy**

A therapeutic program provided for offenders supervised for offenses requiring treatment. Provided by a private vendor.

### **Treatment Court**

An intensive approach to dealing with offenders who have substance abuse problems. The offender works with a team of specialists while learning to make positive decisions.
