

DISTRICT PROGRAMS

Offenders Offering Alternatives- This program, which is facilitated by inmates within the Missouri Department of Corrections, allows offenders to spend a day in a Missouri Department of Corrections institution. This program provides the realities of prison and how poor decisions could result in incarceration within the Department of Corrections.

Victim Impact Panel - The panel provides information to offenders on how alcohol related and other crimes impact victims, their families, and the community.

Sex Offender Group - The Sex Offender Group is designed to provide ongoing treatment for offenders with sexual related offenses. The group is facilitated by a licensed therapist and is held weekly.

Pathways to Change - This program is a cognitive restructuring program that provides education in numerous topics.

Financial Management — This program gives education on issues related to budgeting and basic financial management that affects you on a daily basis.
