

**MRP STEERING TEAMS
UPDATED BASELINE OUTCOME RESULTS & SENTENCING COUNTY
ANALYSIS
RELEASES JULY 1, 2004 TO JUNE 5, 2009**

The MRP research identified nine factors that were important in the understanding of re-entry problems:

1. Education: high school diploma or GED
2. Job skills
3. Completion of the Life skills program (ESLS) for the unskilled
4. Mental Illness
5. Substance Abuse
6. Substance Abuse Treatment
7. Employment status after release
8. Substance abuse after release
9. Social problems after release: domestic relations, finance, medical and mental health problems

An updated recidivism analysis has been completed for each the nine risk/need factors and the recidivism rates for offenders with a skill, attribute or problem are compared to those offenders without the skill, attribute or problem. The recidivism rate is the percent of offenders who have been returned to prison within two years of release, either for a new conviction or for a violation of the conditions of parole. The number of releases in the MRP Steering Team tables is the number of offenders who have been released at least two years. The number of offenders returned to prison within two years can be obtained by multiplying the number of releases by the recidivism rate. The statewide summary analysis for each of the nine risk/need variables has average recidivism rates calculated from six months to three years from release.

All offenders released by the DOC from July 1, 2004 to June 5, 2009 are included in the study and releases by fiscal year and gender are reported after the outcomes analysis, (pages 38-46).

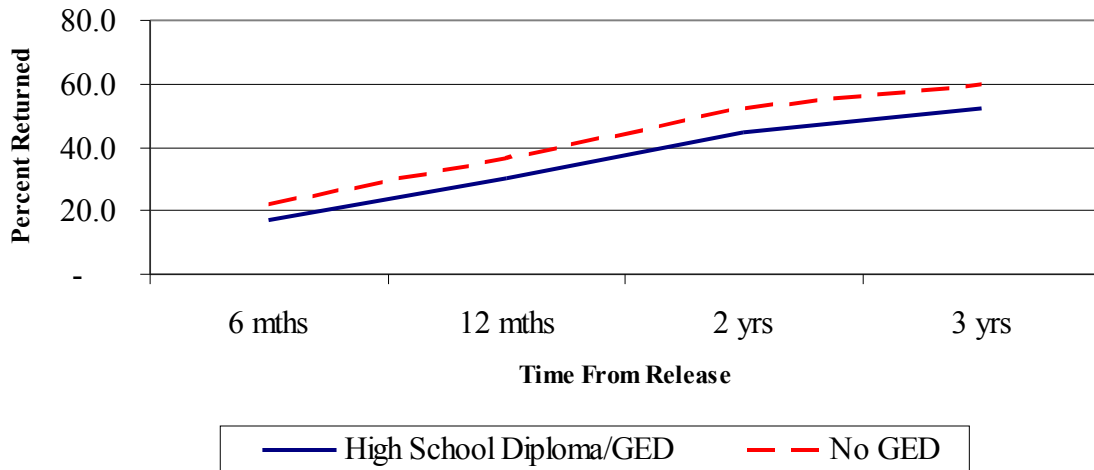

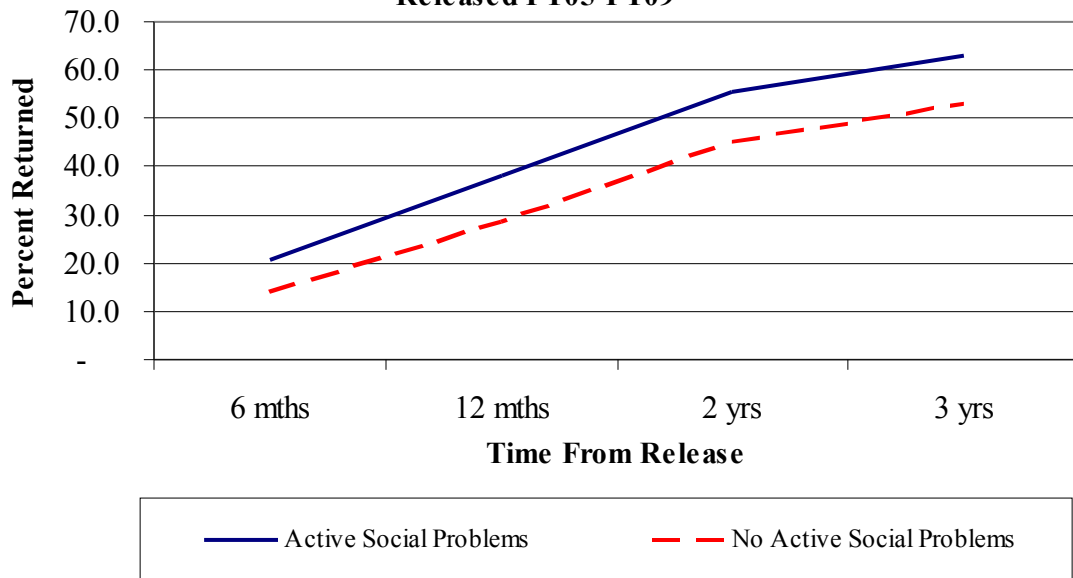
