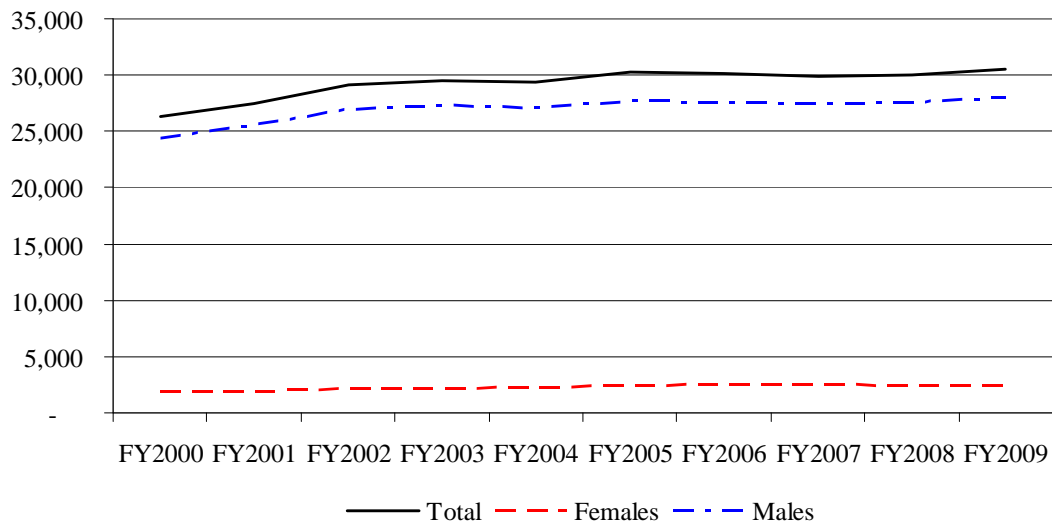

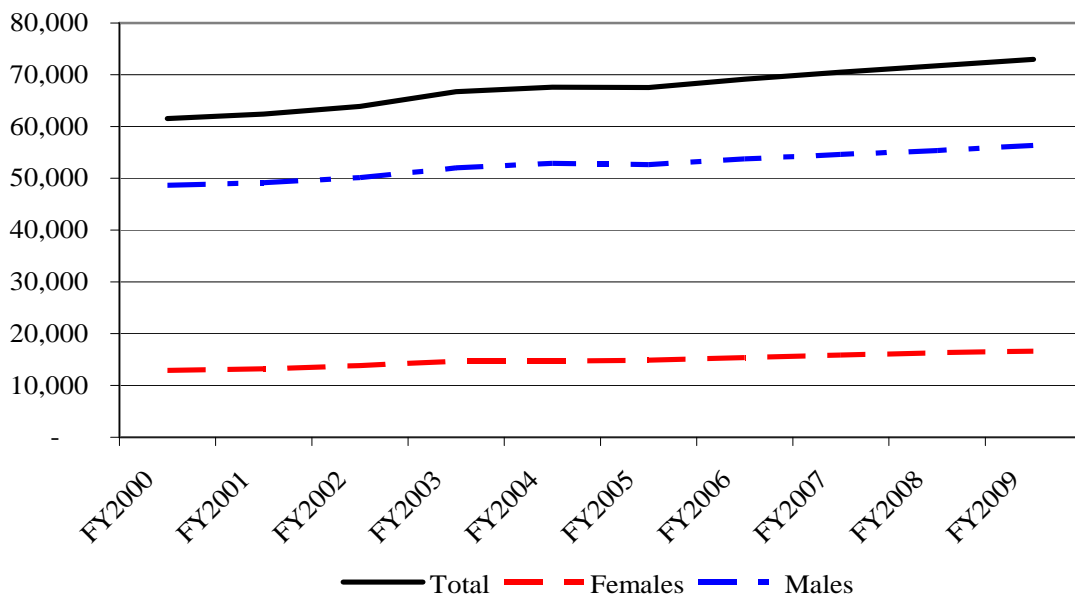

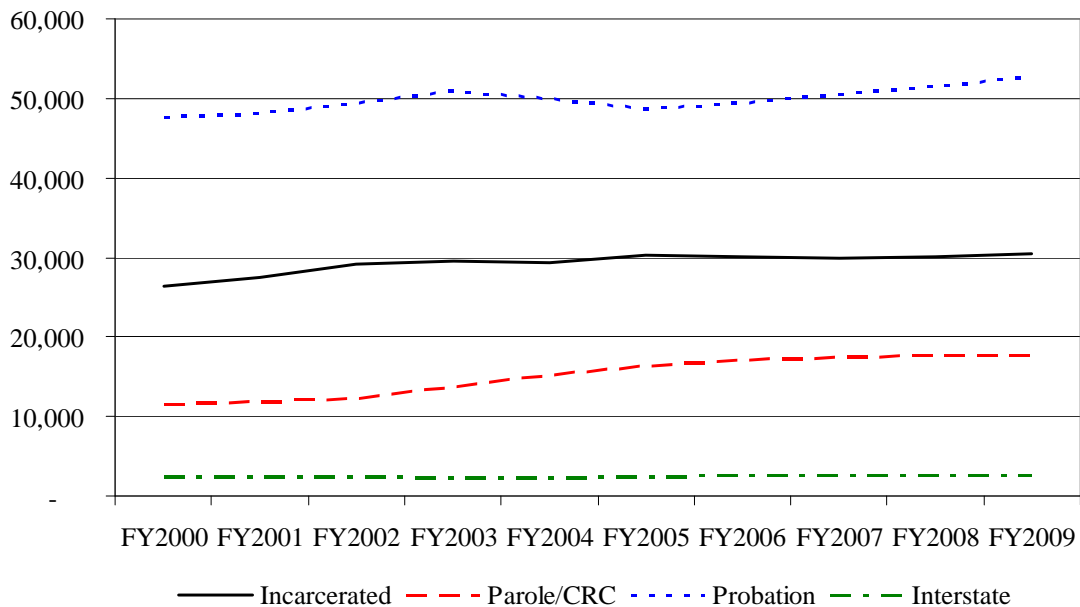

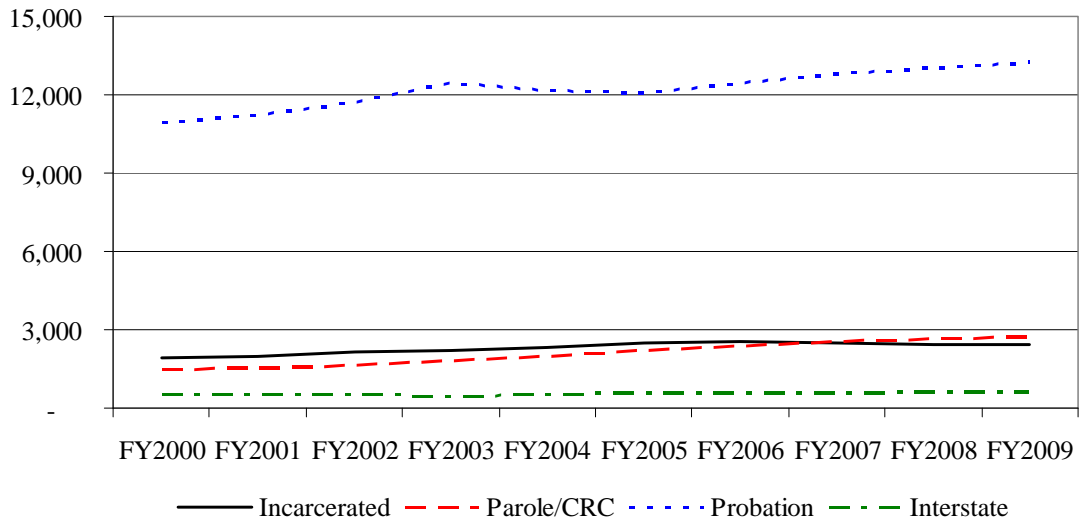

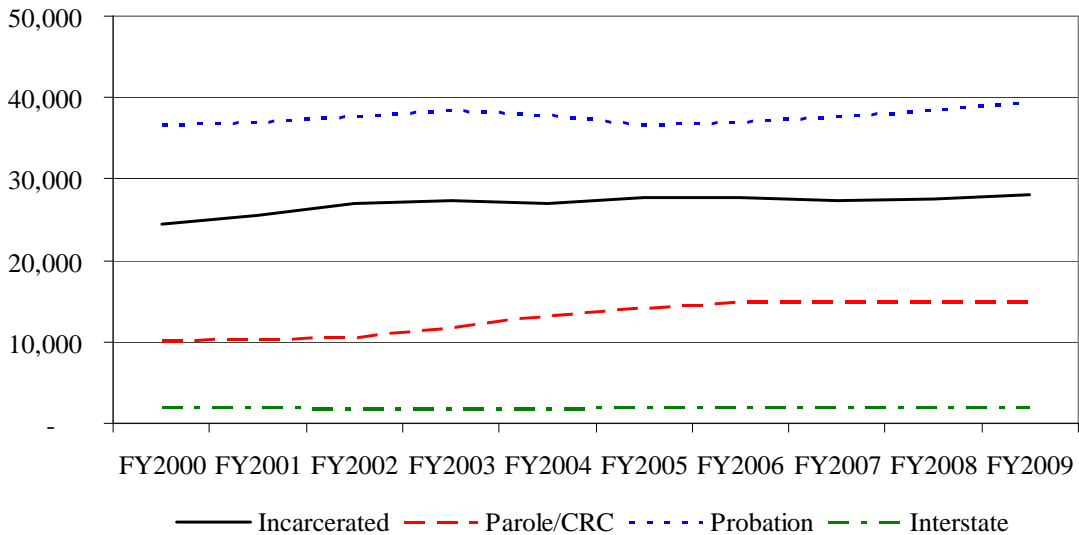
### Total Female DOC Population FY2000 to FY2009

### Total Male DOC Population FY2000 to FY2009





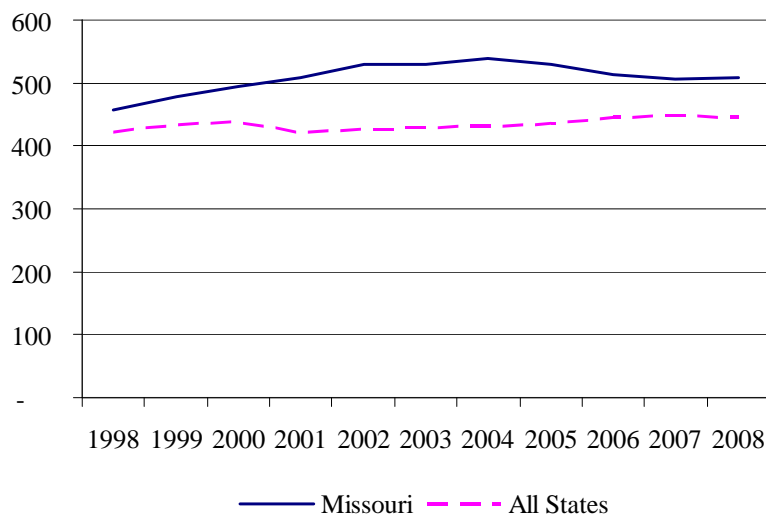

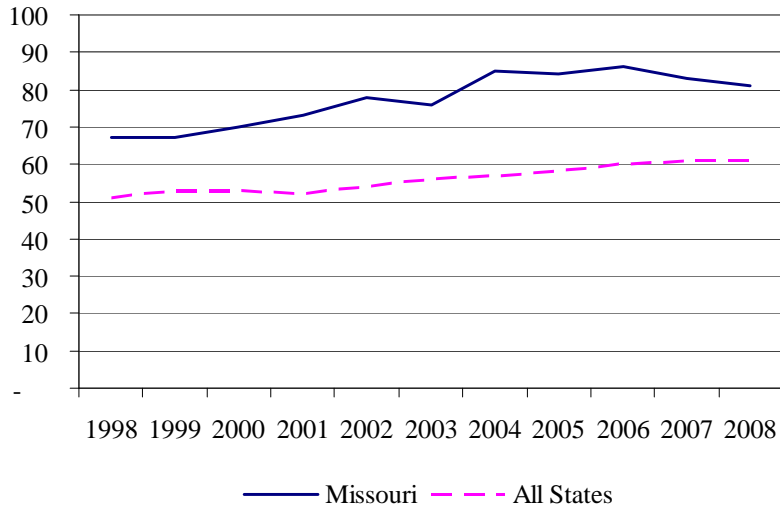

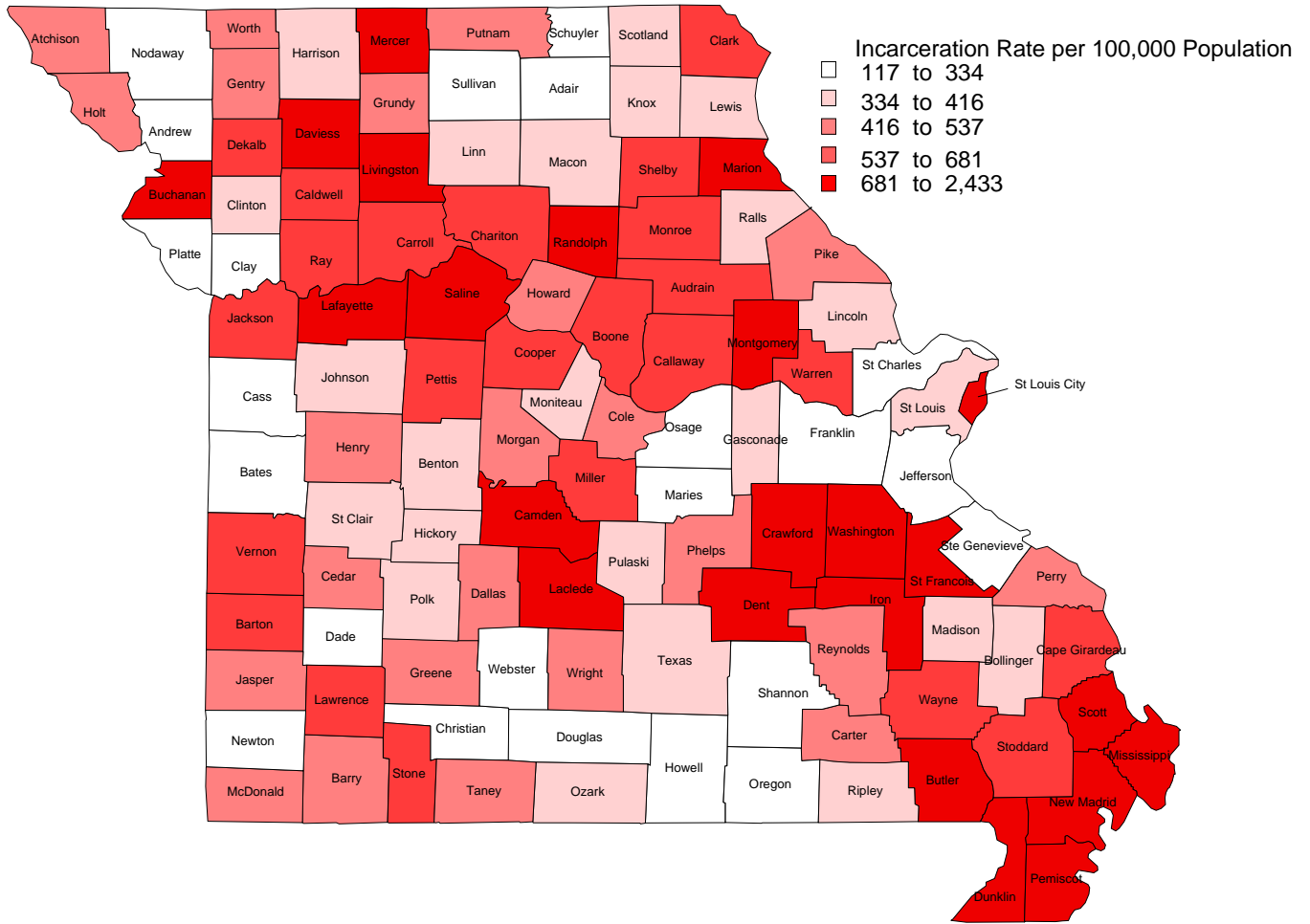

The percent of offenders incarcerated that are dangerous felons has increased from 8.4% in FY2000 to 18.0% in FY2009. Robbery 1<sup>st</sup> degree remains the most populous charge among dangerous felonies. Also note that Murder 1<sup>st</sup> degree is not defined by statute to be a dangerous felony as an 85% minimum served does not apply.

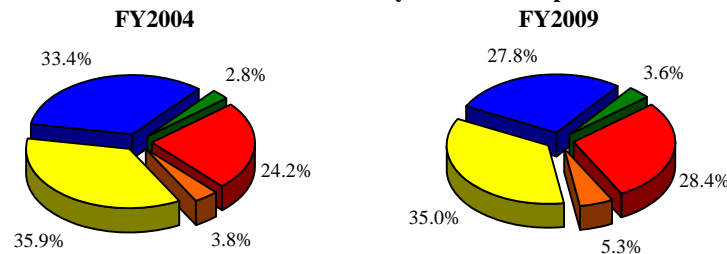

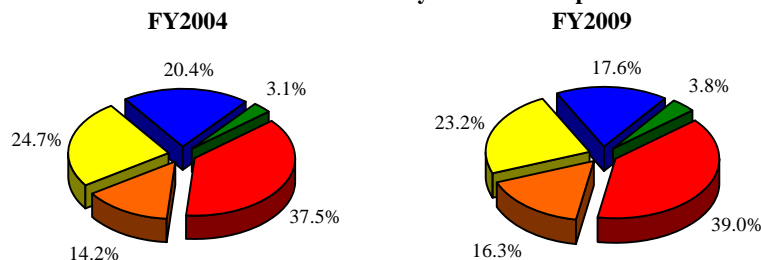

■ Violent ■ Sex ■ Nonviolent ■ Drug ■ DWI

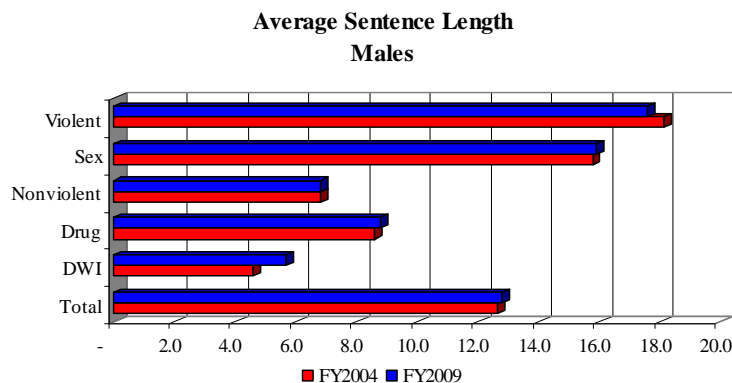
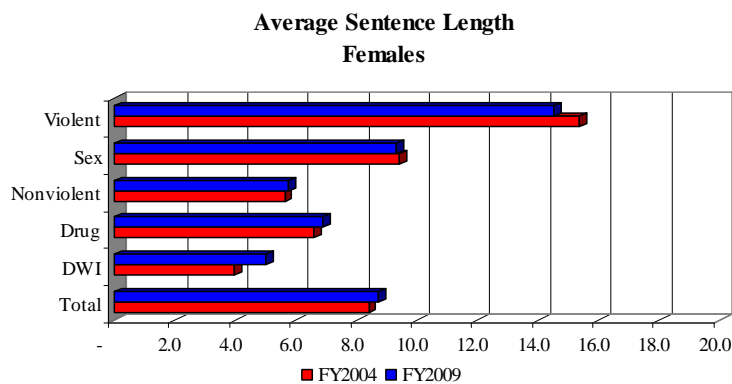
The female offender population has increased 6.2% from FY2004 to FY2009 while the male population has increased 3.6% over the same time period. The largest increase occurred among female sex offenses. These include child abuse offenses, excluding non-support offenses. The number of offenders incarcerated for drug related offenses has decreased 10.8% from FY2004 to FY2009.

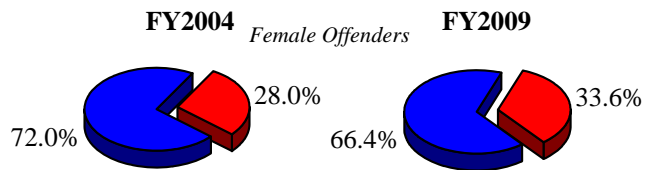
The average aggregate sentence of all incarcerated offenders has increased 1.4% from FY2004 to FY2009. Average sentence length for females have increased 3.7% while the average sentence length for males has increased only 1.3%. In both male and female offenders, the largest increase in average sentence length was among DWI offenders. For offenders incarcerated on June 30, 2009, female offenders were serving an average sentence of 8.7 years and male offenders were serving an average sentence of 12.8 years.

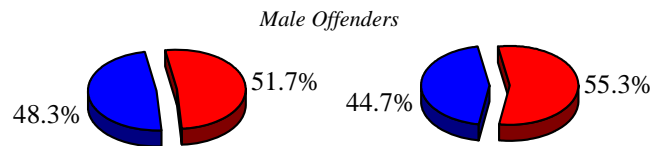

Total admissions to prisons have decreased at 1.1% per year in the last five years compared to 7.8% from 2000 through 2004. New admissions to prisons have increased at 0.1% per year in the last five years compared to 3.6% from 2000 to 2004. What is of significance to the department, because of the impact upon the prison bed capacity, is the increase in new admissions that are sentenced to a prison sentence. From FY2000 to FY2004 the new term admissions increased 6.8%, but since 2005 the average annual increase has slowed to 1.5%.

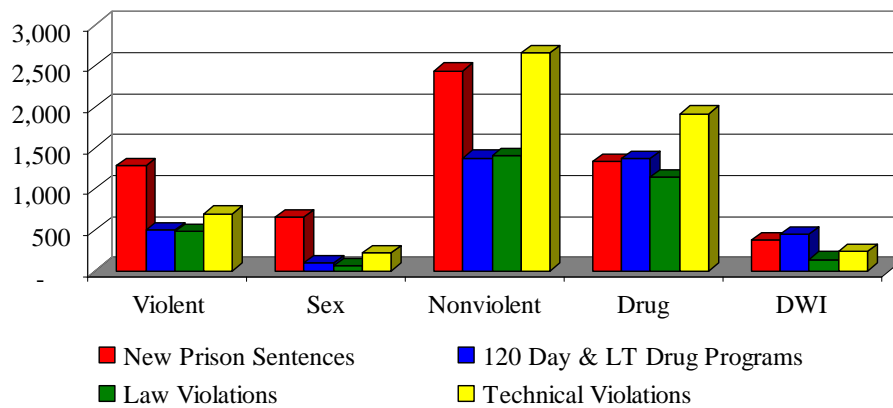

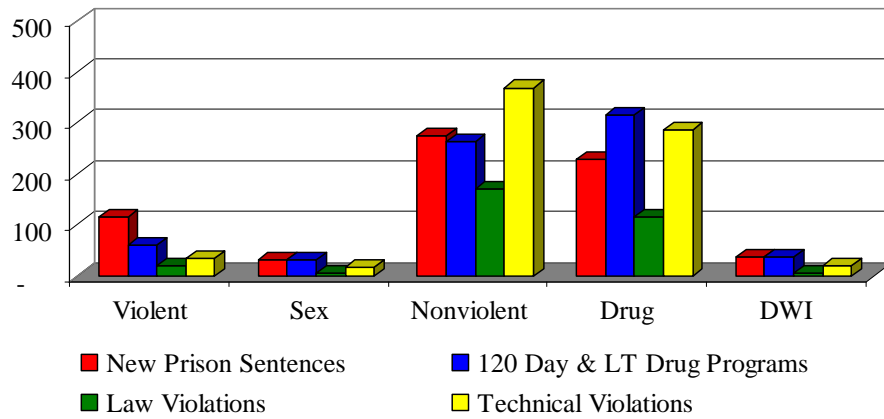

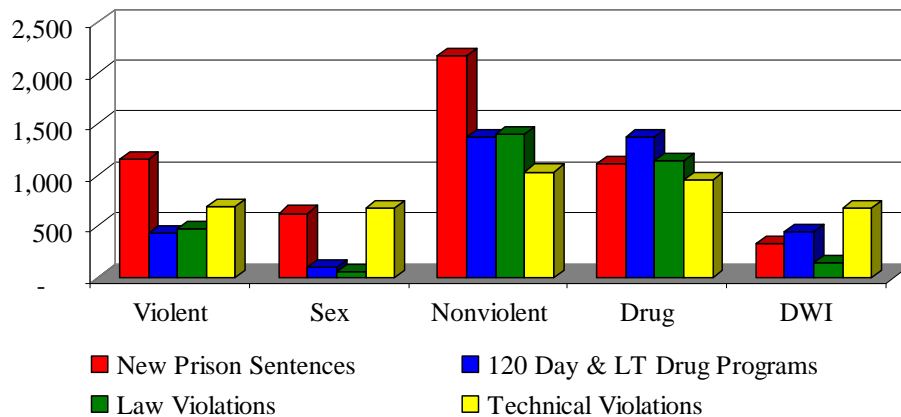

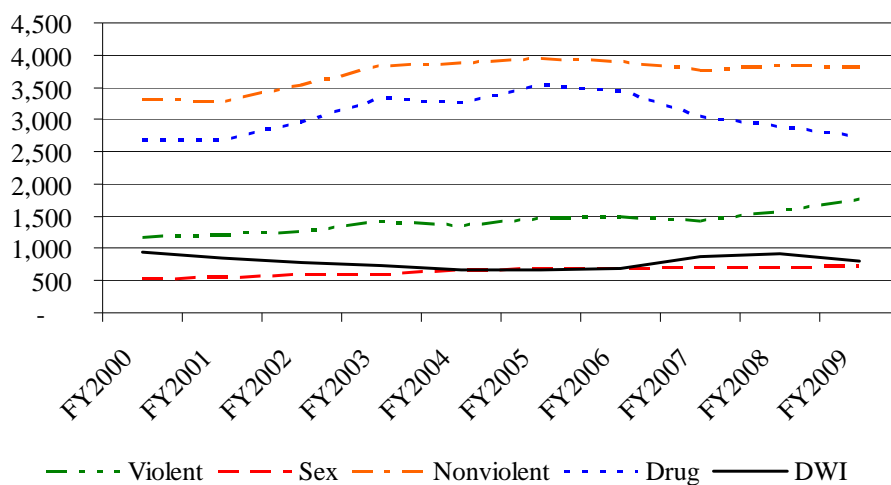

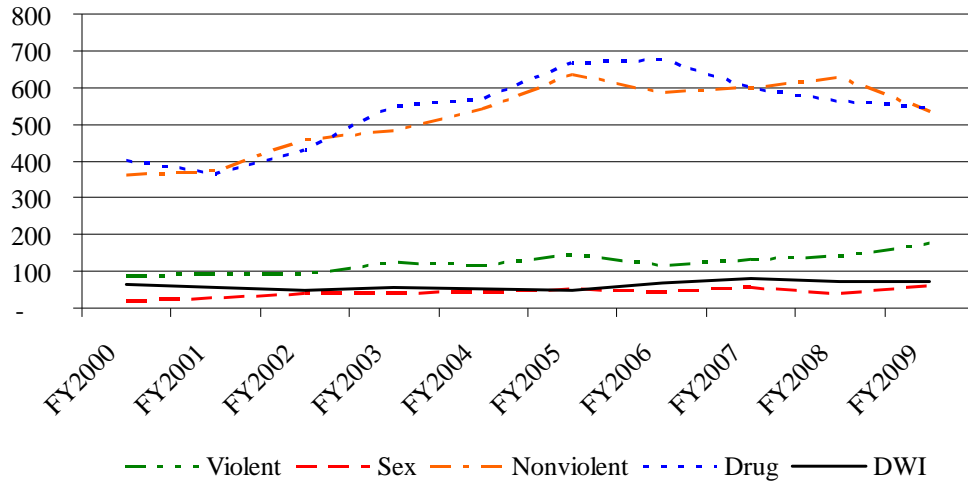
New Admissions by Offense Group, FY2000 to FY2009

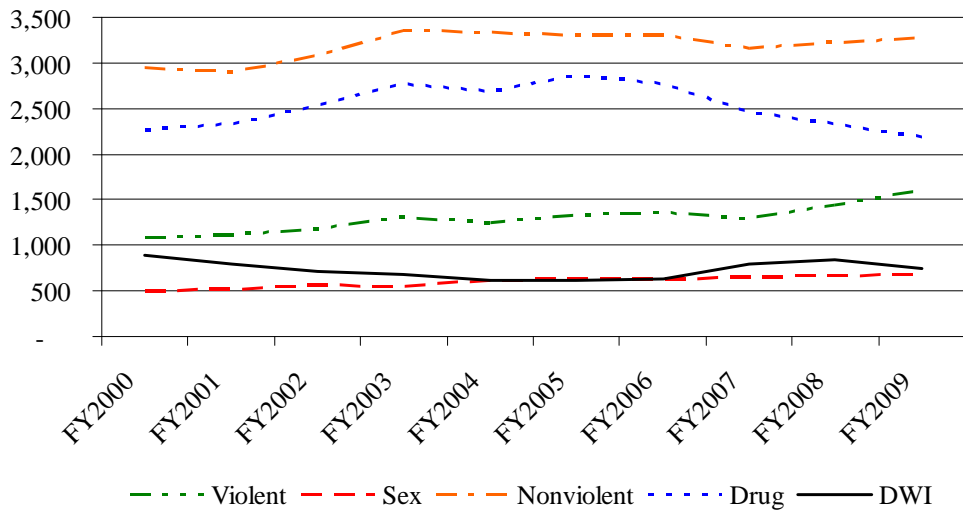

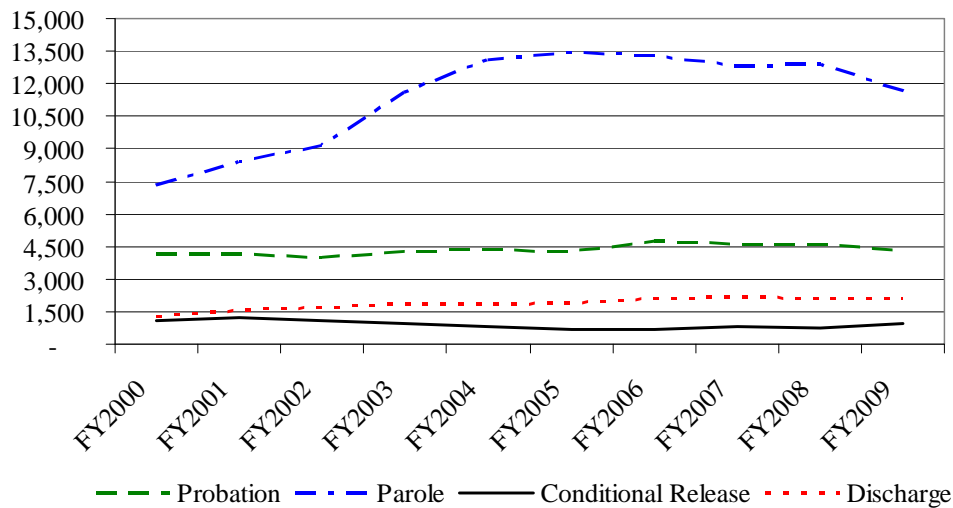

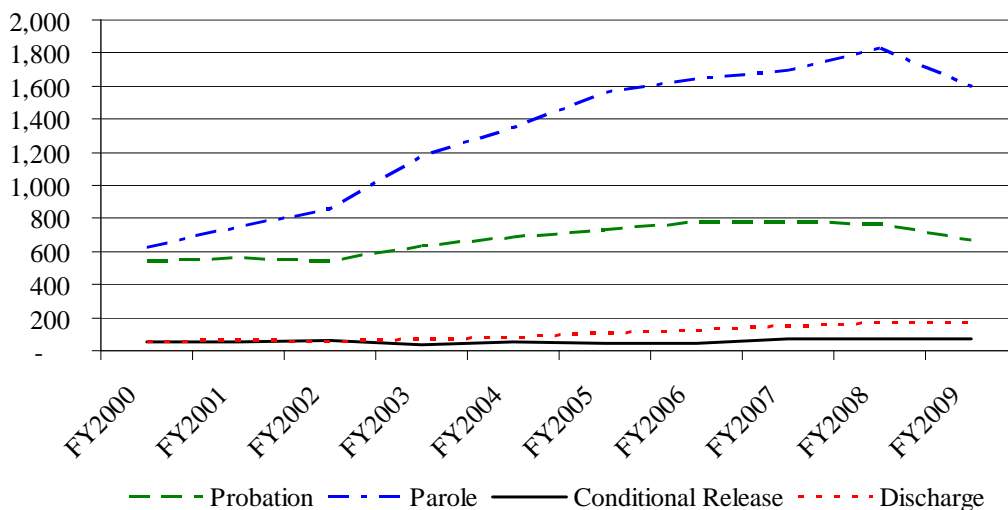

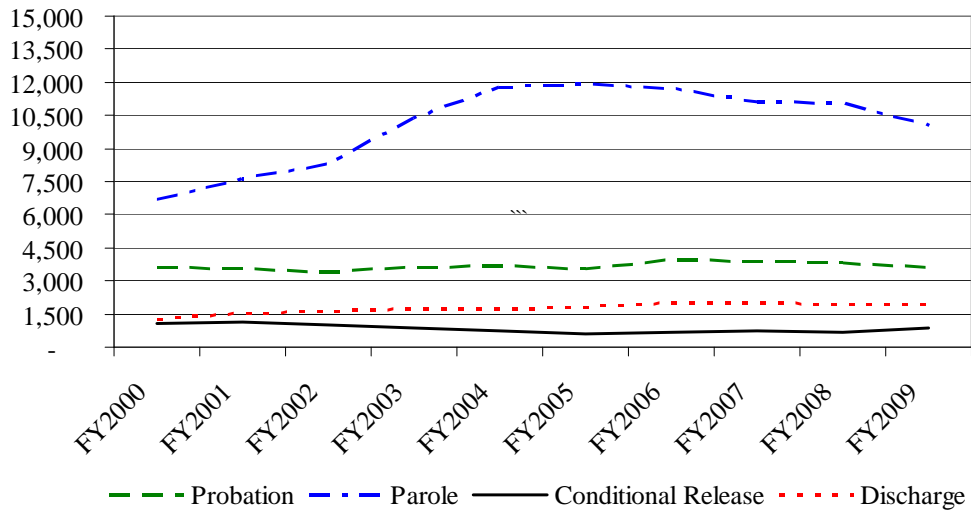
The number of females released to parole has more than doubled since FY 2000 while the number of female offenders released on the conditional release date had been reduced from FY 2003 to FY 2006.

**Authorized Male Releases from Prison FY2000 to FY2009**



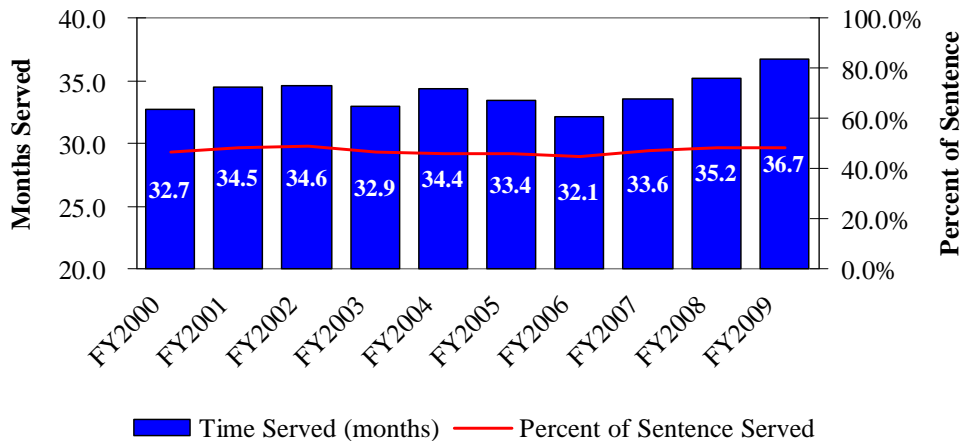
## 7. Time Served to First Release

Time served as a percent of the sentence in FY 2009 increased from 48.0% in FY 2008 to 48.5%. At 36.7 months, the average time served in 2009 is the highest it has been since 2000. This increase can, in the main, be attributed to an increase in time served by offenders convicted of violent and sex offenses. Offenders convicted of offenses committed August 28, 1994 have to serve a minimum prison term if they have committed a dangerous felony (85%) or have prior incarcerations with the Missouri Department of Corrections (40% on prior, 50% two priors and 80% three or more prior incarcerations). Time served includes jail time that is credited to an offender's sentence for incarceration prior to receipt by the Department of Corrections. Offenders convicted of a sex offense in Chapter 566 RSMO have to complete the Missouri Sex Offender Program before being eligible for a parole release.

### Time Served to First Release FY2000 to FY2009



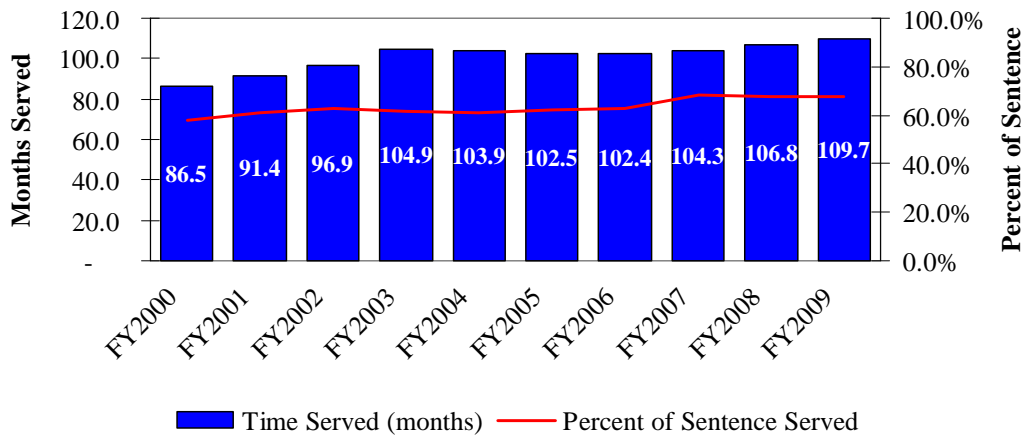

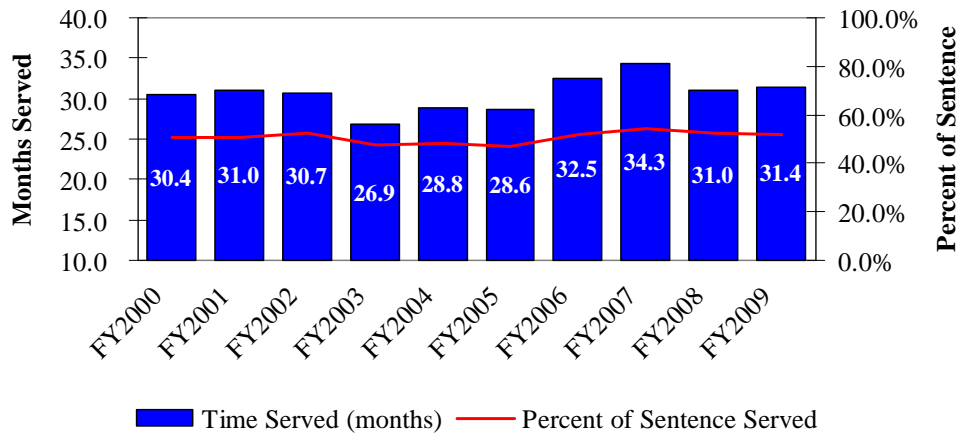
**Time Served to First Release

C and D Violent Felonies FY2000 to FY2009**

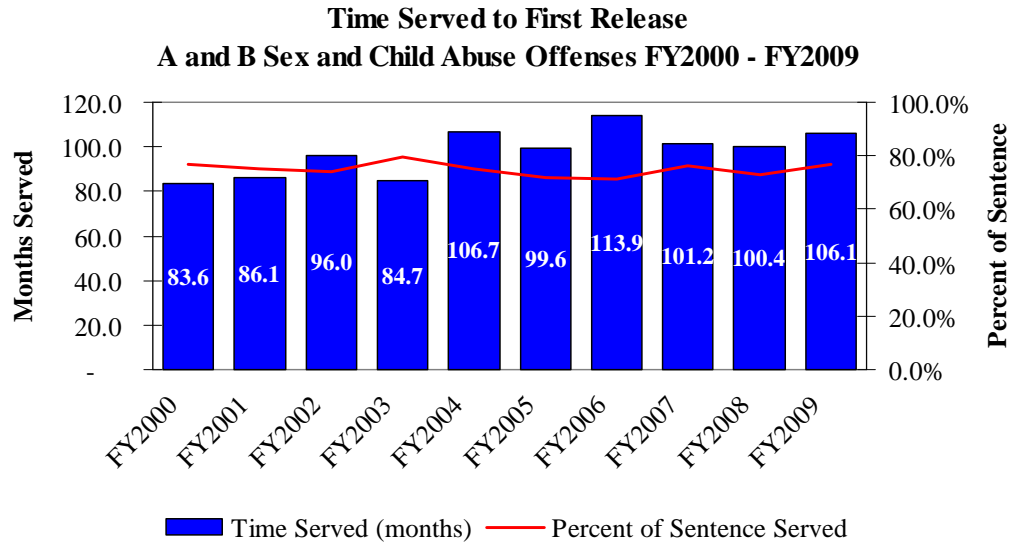

C and D Violent Felonies FY2000 - FY2009**



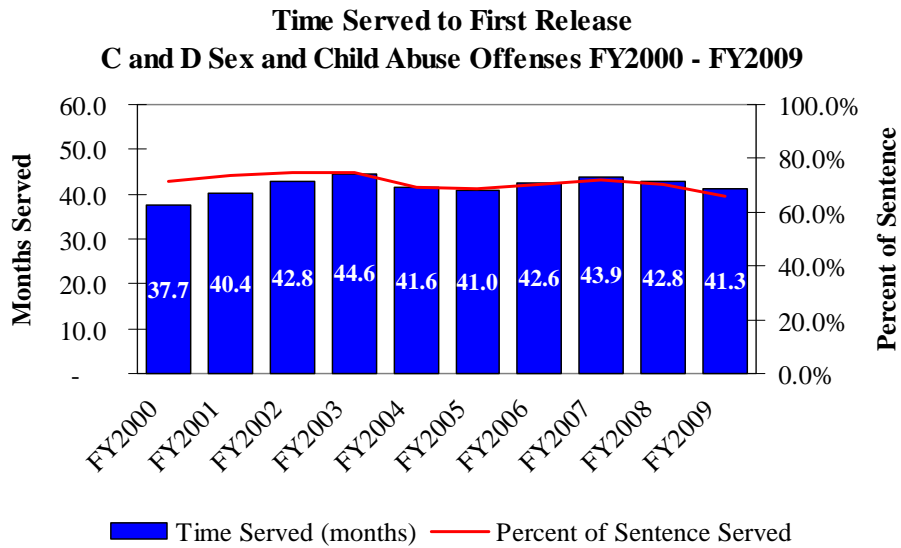

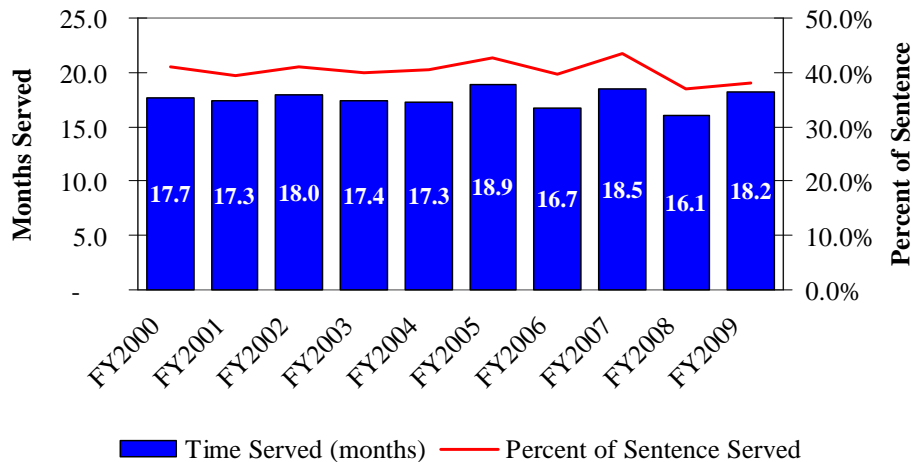

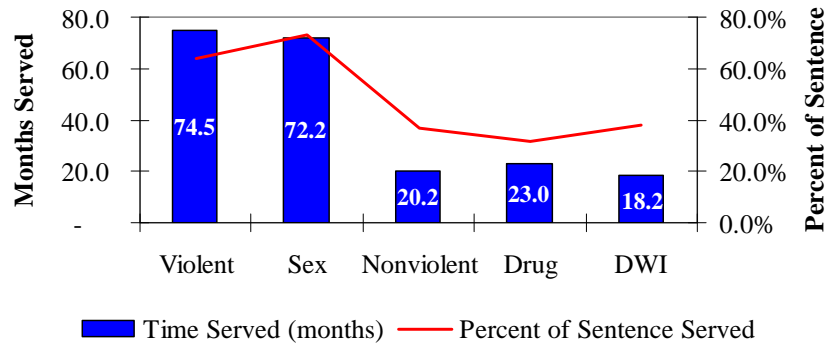
**Time Served to First Release

## **8. Recidivism Rates by Institutional Releases**

There are many ways to measure recidivism and there are no national standards. The rates calculated by the Missouri Department of Corrections and included in the Offender Profile are for offenders first released in the commitment. These are offenders admitted to prison to serve a new commitment and released to either parole, conditional release or on the discharge of the sentence. Excluded from the calculation is the release of parole violators who have previously been returned to prison for a violation of supervision within the commitment. Recidivism rates that include the release of parole violators are higher than the first release recidivism rates.

The recidivism rates measure two outcomes:

1. The first return to prison following the release (technical violation of supervision or new conviction),
2. The first conviction following the release from prison (the new conviction can be a new prison sentence or probation. Because many offenders returned from parole are returned for a technical violation) the new conviction recidivism rate is not a very helpful indicator of new criminal behavior until two or more years from release.

The data for the calculation of the rates are taken from the DOC offender database. Offenses and incarcerations in other states will not be included unless the offender is returned to the custody of the DOC.

Other recidivism rates are given in the Offender Supervision profile for offenders released to probation following a 120-day or long-term drug program and for offenders serving a new court probation.

There was a change in the measurement of recidivism in the FY06 Offender Profile. The first release population includes offenders who abscond from a community release center. Because the majority of offenders who abscond are returned to prison, the change has resulted in an increase in the recidivism rate compared to the rates shown on the FY05 Offender Profile. Offenders who absconded from community release centers were previously excluded from the recidivism rates because, before the Board of Probation and Parole took over the operational management of the community release centers, offenders were normally released to community release centers on inmate status.

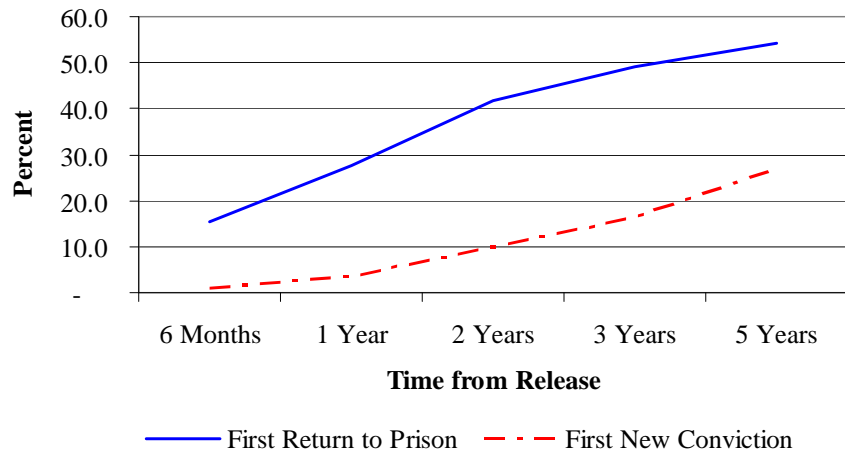

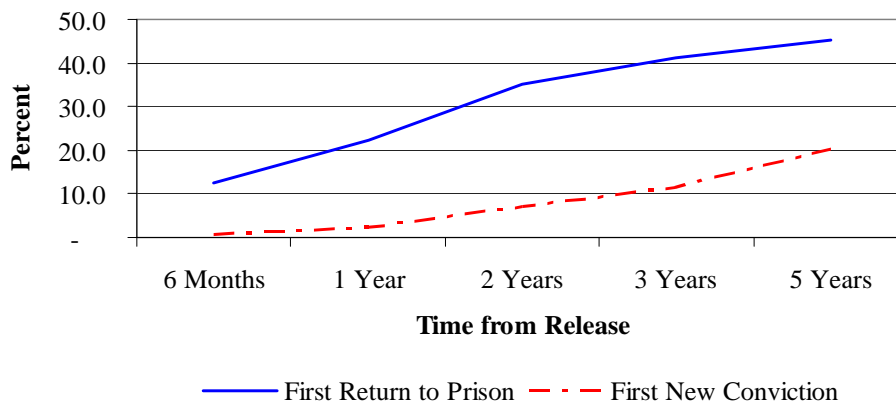

**Female Recidivism Rates, First Released FY2000 to FY2009**



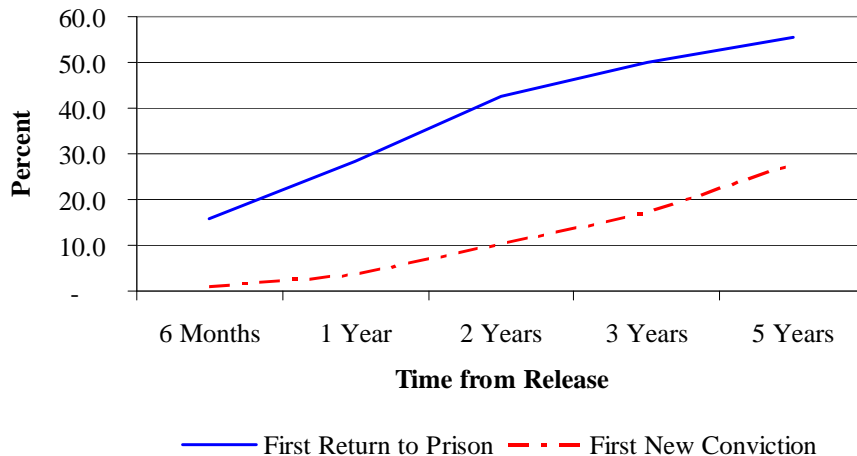

**Male Recidivism Rates, First Released FY2000 to FY2009**

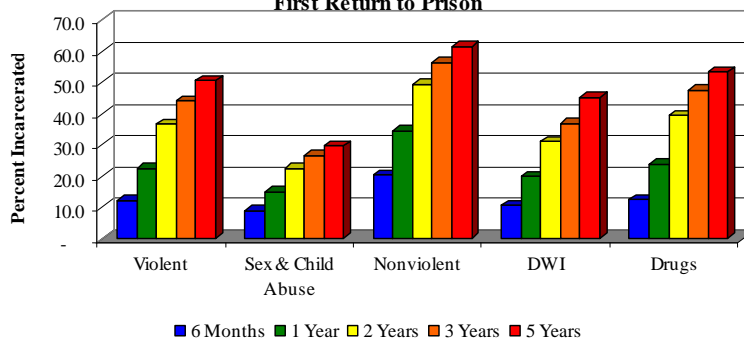

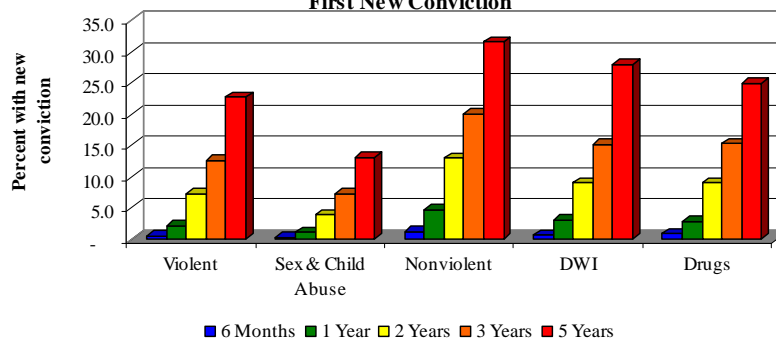
### Recidivism Rates by Offense Type, First Released FY2000 to FY2009 First Return to Prison

## 9. Sex Offender Population

The sex Offender Population comprises offenders convicted of an offense in Chapter 566 (Sexual Offenses) or of a child abuse offense in Chapter 568 (Offenses against the family) or convicted of failing to comply with the sex offender registration laws in Chapter 589 (Crime Prevention) of the Missouri Revised Statutes.

The sex offender population of 4,694 comprises 15.4% of the total incarcerated population. Of that number 73.5% were from the ages 20 to 44, and 97.2% were male and 71.0% were white.

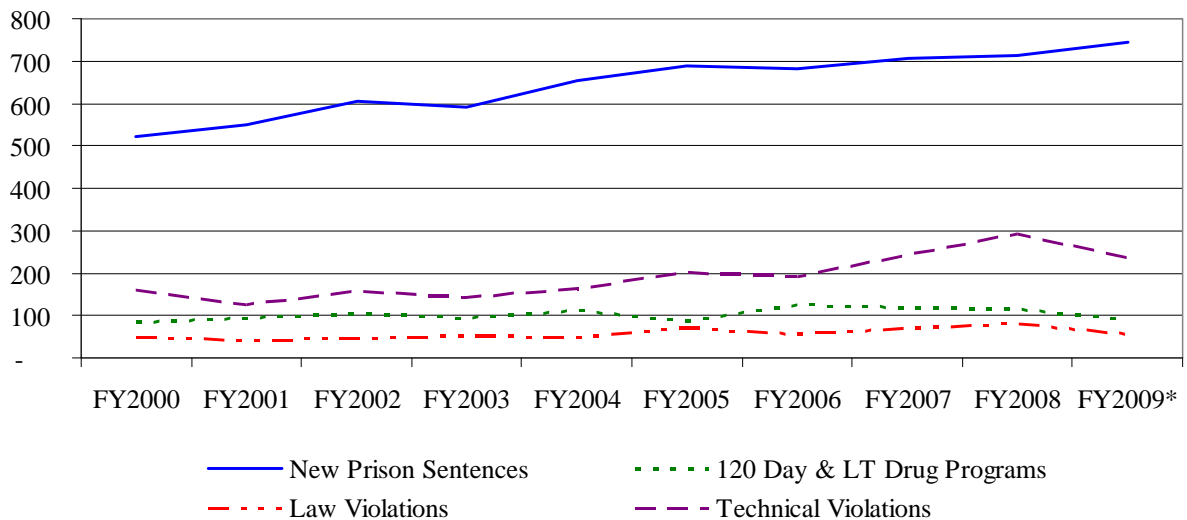

### Time Served to First Release

Offenders convicted of offenses committed after August 28, 1994 have to serve a minimum prison term if they have committed a dangerous felony (85%) or have prior incarcerations with the Missouri Department of Corrections (40% one prior, 50% two priors and 80% three or more prior incarcerations). Time served includes jail time that is credited to an offender's sentence for incarceration prior to receipt by the Department of Corrections. Offenders convicted of a sex offense as defined in 589.015 are required to complete the Missouri Sex Offender Program before being eligible for parole or conditional release.

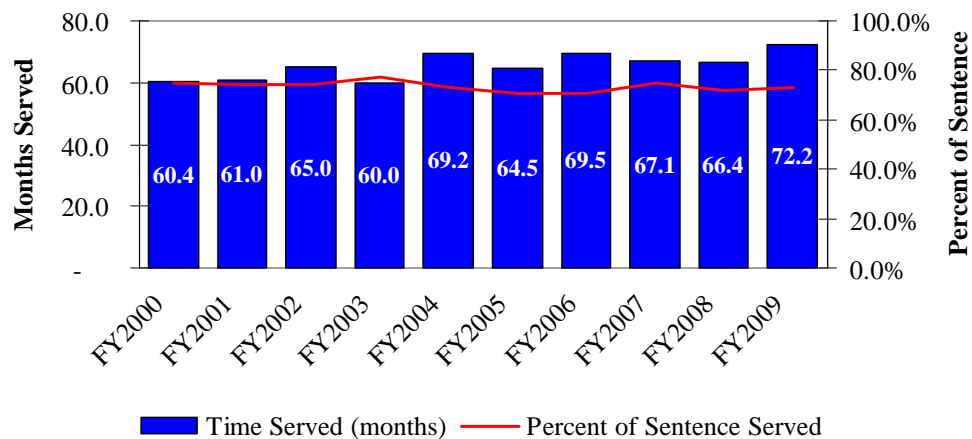

Sex Offenses FY2000 to FY2009**



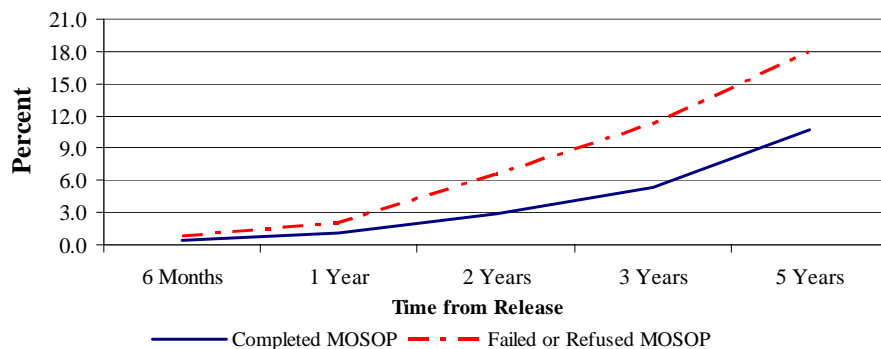

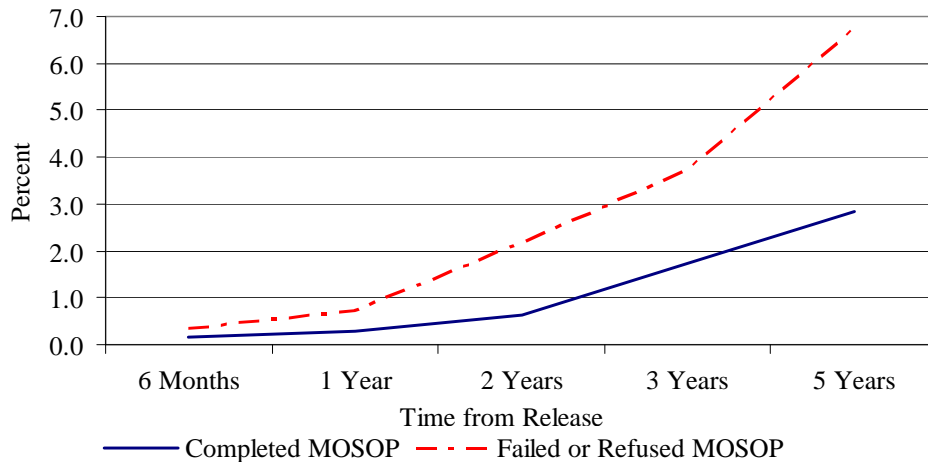

First New Sex Conviction**

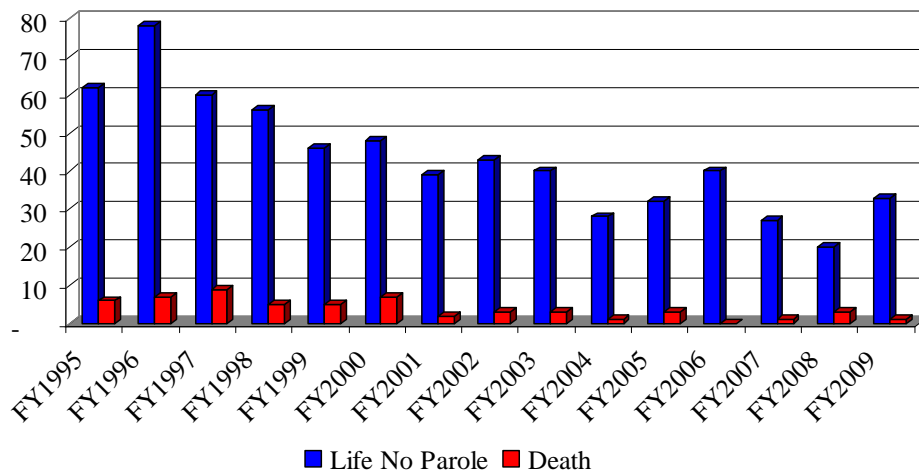

Execution is an authorized punishment for offenders convicted of Murder 1<sup>st</sup> degree. Offenders not sentenced to death must serve life without parole. The first execution in Missouri following the US Supreme Court decision authorizing the legality of capital punishment statutes took place in 1989, although the new capital punishment law became effective in Missouri on May 26, 1977. From June 30, 1991 to June 30, 2008 there have been 64 executions.

The statistics count offenders on the first admission by the Department of Corrections for a conviction of Murder 1<sup>st</sup> degree for an offense committed after October 1984 or a conviction for capital murder prior to October 1984. Prior to October 1984, Murder 1<sup>st</sup> degree allowed parole. Re-sentencing and commutation of the death penalty are not included in the charts.

Females



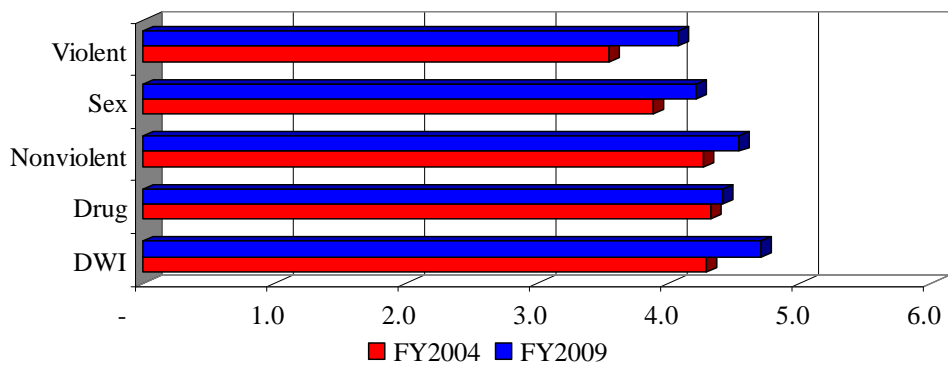

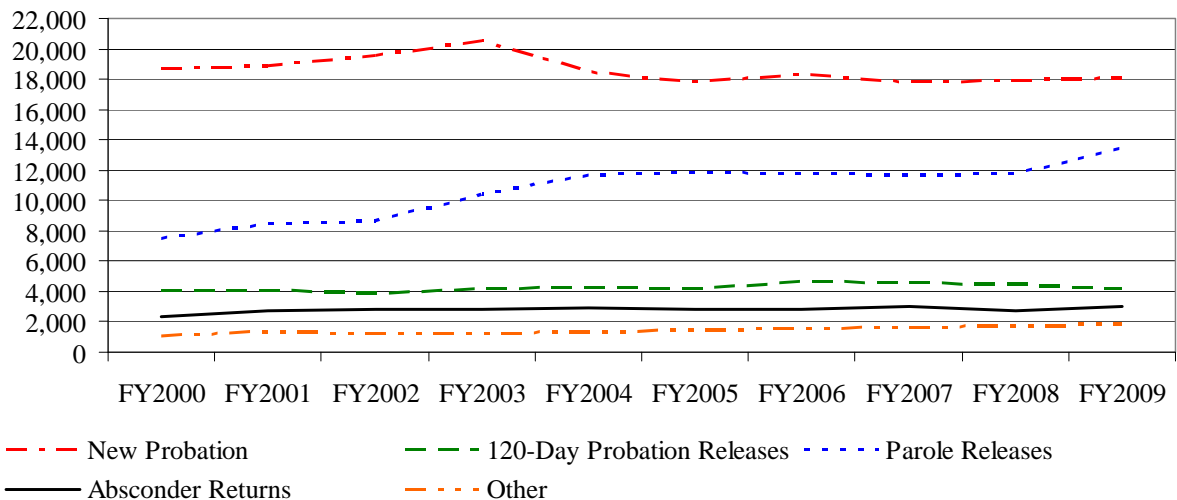

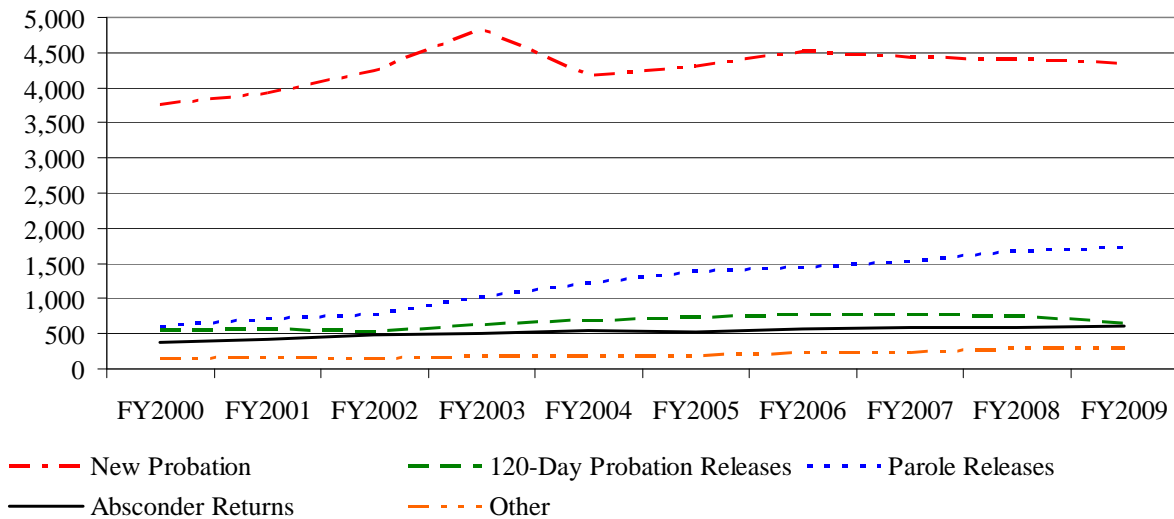

Senate Bill 5 enacted in 2003 removed non-violent misdemeanor cases from DOC probation supervision, and this has been the main reason for the decline in new court probations.

Probation following a court stipulated 120-day program has decreased significantly from 9.0% per year (FY 2000-2004) to -0.6% (FY 2005-2009).

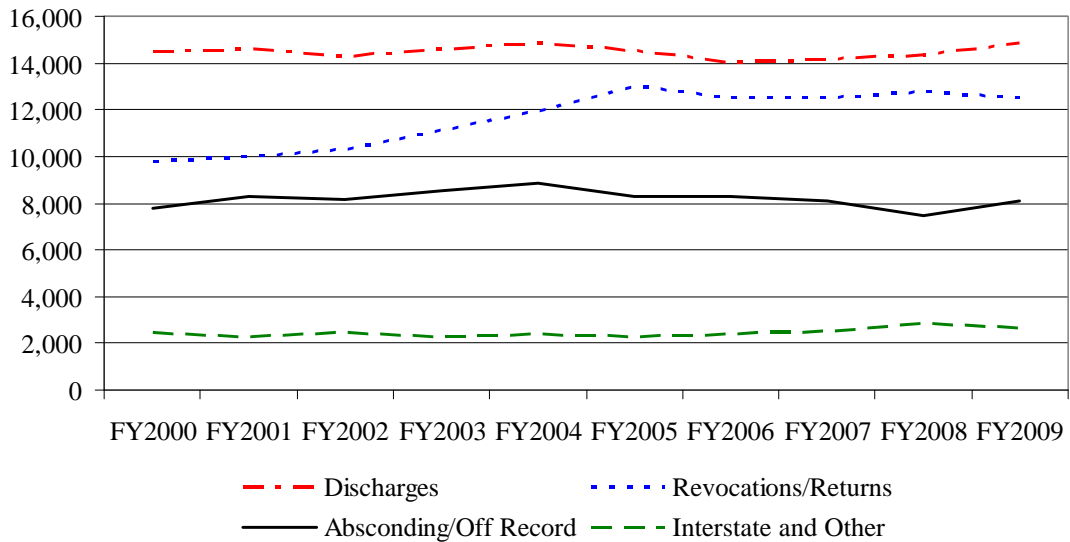

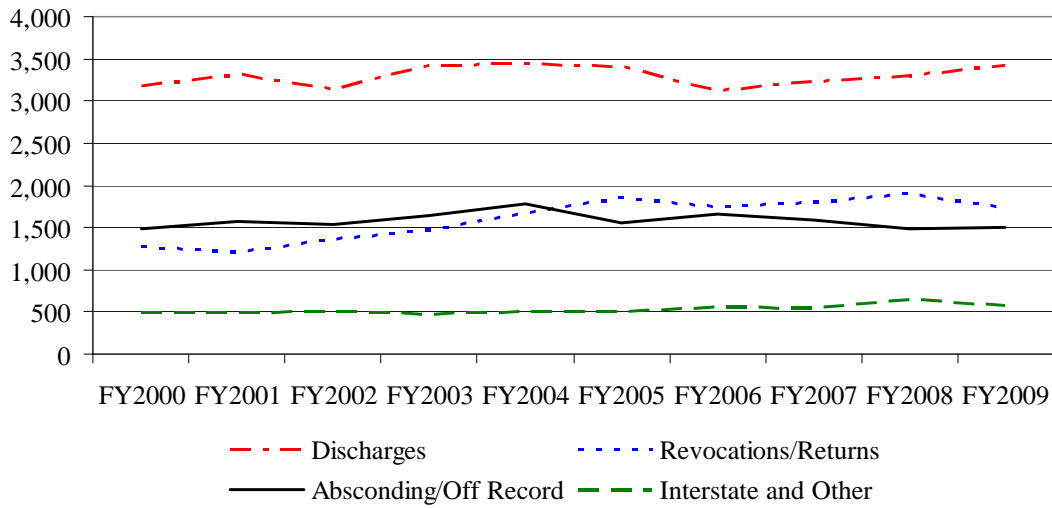

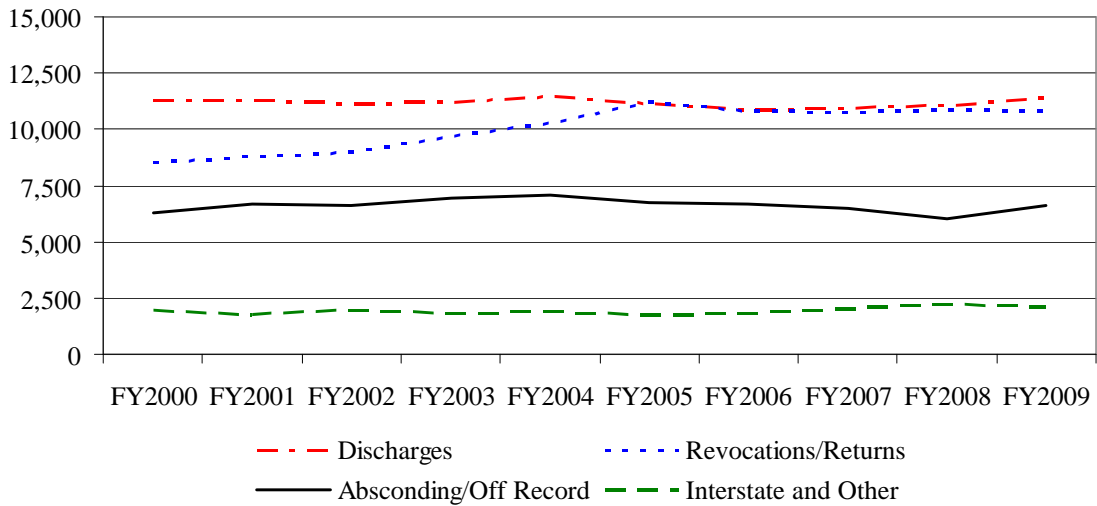

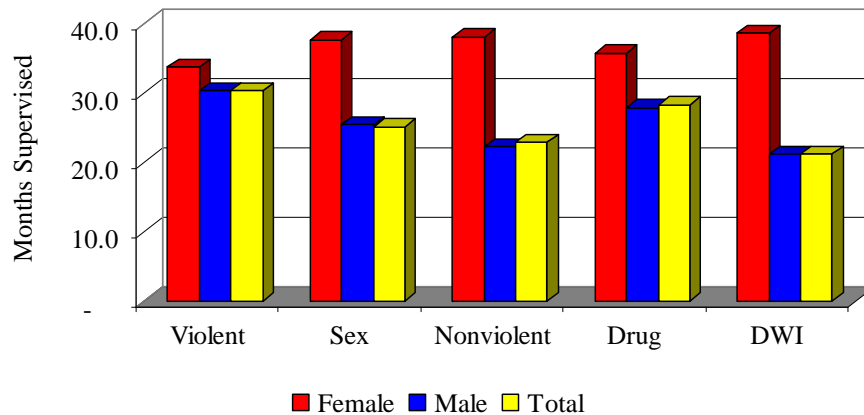

Offense Group for FY2009**

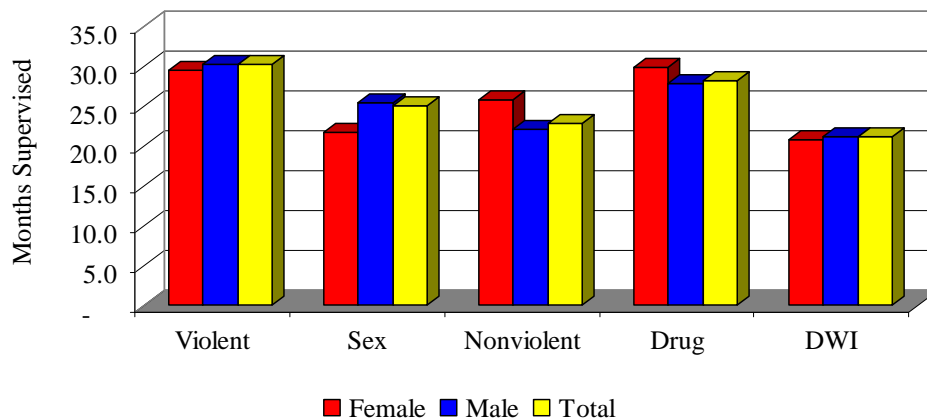

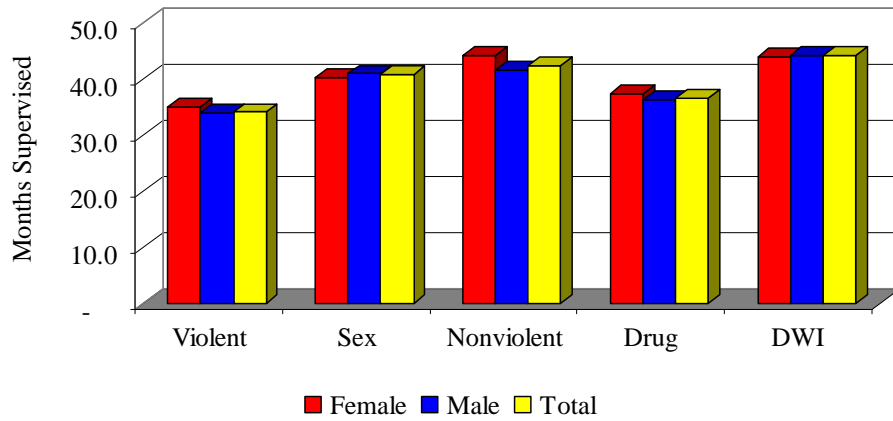

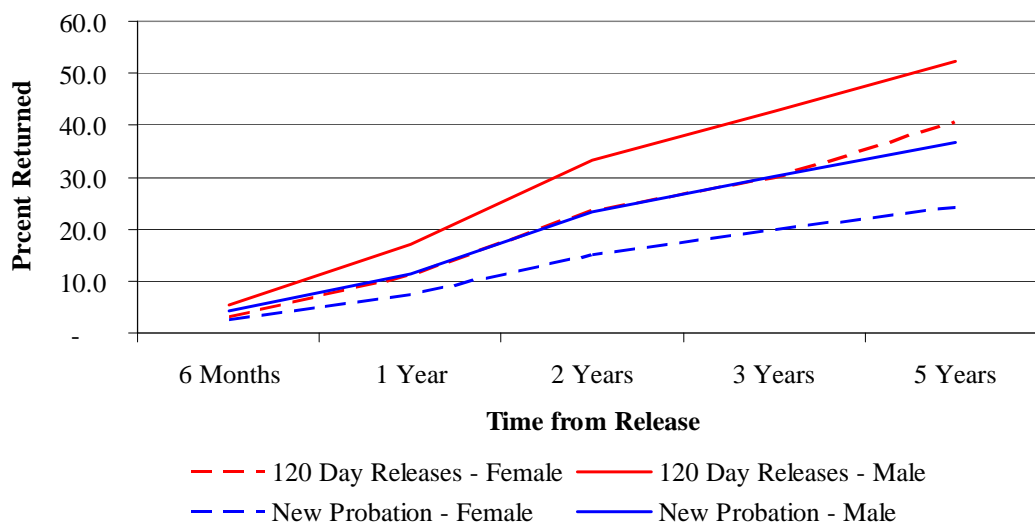
