

INTAKE - This is a one time group designed for persons that are new to Probation and Parole. Us while on supervision.

INTERVENTION FEES - All clients under supervision will pay a monthly Intervention Fee of \$30.00, as required by 217.690 RSMo, for the term of their supervision. Payments are due and payable on the first day of each month. Ask your Officer for details.

**DRUG COURT** – An intensive approach to dealing with offenders with substance abuse problems. The offender works with a team of specialists while learning to make positive decisions while on supervision.

**PATHWAYS TO CHANGE** – A cognitive restructuring program to help offenders make positive choices and changes.

**SEX OFFENDER THERAPY** – A therapeutic program provided for offenders supervised for offenses requiring treatment.


## INTERVENTION FEE
