

## DISTRICT PROGRAMS

Drug Court: An intensive approach to dealing with offenders with substance abuse problems. The offender works with a team of specialists while learning to make positive decisions while on supervision.

Pathways to Change: A cognitive restructuring program to help offenders make positive choices and changes.

Sex Offender Therapy: A therapeutic program provided for offenders being supervised for offenses requiring treatment.
