Intake: Orientation program for first-time offenders. The conditions of supervision are reviewed along with information about community resources and how to successfully complete your probation or parole. Family members and significant others are encouraged to attend with you!

PUPS (Puppies Uniting People Successfully)

The first of its kind in Missouri, this is a community-based adaptation of the Department's Puppies for Parole Program, operated out of our district office in Cape Girardeau. It is an honor program that unites the community, offenders, and P&P staff to socialize and train dogs at a local shelter to promote their well-being and adoptability.

Treatment Court: An intensive approach to dealing with offenders who have substance abuse problems. The offender works with a team of specialists while learning to make positive decisions.

Various other program are offered periodically, both in-house and by area service providers. See your Probation and Parole Officer for more information.
