### INTERVENTION FEE

Under Missouri Law, all persons under supervision are required to pay a monthly supervision fee of \$30.00, due by the 1<sup>st</sup> of each month. Payments options include: Automatic Withdrawal, web, phone and/or by money order or cashier's check.
