## DISTRICT PROGRAMS

**Offenders Offering Alternatives (Prison Tour) -**  
This program, which is facilitated by inmates within the Missouri Department of Corrections, allows clients to spend a day in a Missouri Department of Corrections institution.

**Intake Group -** Initial group attended by all new probation and parole clients to go over their orders of supervision and also to discuss office procedures and requirements.

**Pathway to Change -** This program is a cognitive restructuring program that provides education in numerous topics.

**Reality House** – Residential Facility for parolees who are referred by the Parole Board or Probation & Parole Officer.

## MISSION STATEMENT

*The Missouri Board of Probation and Parole, as an essential part of the criminal justice system, is to provide for the professional assessment and release of offenders and their supervision in the community, using appropriate treatment, sanctions, and controls, with the primary consideration being the promotion of public safety.*

## INTERVENTION FEE
