

DISTRICT PROGRAMS

P. E. A. C. E. Program

The program is designed to identify and address Employment barriers ex-offenders face. Components include; high school equivalency classes, life skills training, community service, cognitive behavioral classes, substance abuse education, healthy relations class, nutrition education, STD/HIV testing, and a computer lab to assist in resume writing and employment search.

Intake Program

An one hour session provided to new clients during the initial assessment phase to help them understand probation and parole supervision and prepare them to achieve a successful outcome. Intake sessions are held the first Monday and Tuesday of each month at 12:00 p.m. and 6:00 p.m. (Schedule subject to change.)

HSE Program

An onsite class with a certified teacher; provides testing and one on one assistance if needed to clients in acquiring a High School Equivalency Diploma.

Substance Abuse Education Classes

A 10 session group orientated class designed to eliminate the advancement of substance use and abuse through education and prevention techniques that focuses on prevention of advancement of substance abuse/use. The program runs every Tuesday at 10:30 a.m. to 12:00 p.m.

Vocational Rehabilitation

Designed to help individuals with physical and or mental impairments obtain employment. Screenings once per month.

Pathways to Change

A 12 week cognitive restructuring program geared to help clients re-evaluate their decision making process so they can make better choices.

Options for Justice

Options For Justice provides support services for persons with developmental disabilities as they navigate the criminal justice and social service system.

Men's Self Help Group

A 10 week program for men to discuss specific topics and seek guidance and support from peers in a healthy way.

Significant Others' Group

This group provides significant others an opportunity to be involved in the supervision process. The group familiarizes the significant others with Probation and Parole. Resources are provided and questions are answered. Significant others will be made aware that Probation and Parole is here to help and ensure supervision is successfully completed.
