

## **DISTRICT SUPERVISION CASELOADS**

### **Regional Level I Supervision -**

*Supervision of offenders who have demonstrated basic stability and responsibility and are complying with granting authority and agency expectations. Offenders are required to report on a monthly basis.*

### **Regional Out of District Caseload-**

*Consists of offenders that have been placed on probation in St. Louis City and/or County residing in another Missouri county.*

### **Regional Out of State Caseload-**

*Consists of offenders that have been placed on probation in St. Louis City and/County residing in another state.*

### **Regional Confined Caseload-**

*Monitoring of cases where the offender under probation supervision in St Louis City/County is confined for one year or more in a state or federal institution.*

*District ERA houses the regional training coordinator, the regional volunteer coordinator and a Probation and Parole Assistant.*
