

## DISTRICT PROGRAMS

**Drug Court:** A Court designed to assist participants in the recovery process, while reducing community victimization, restoration of families and participant success.

**DWI Court:** A Court approach to accountability and community safety for DWI offenders, providing participant's treatment alternatives verses institutional incarceration.

**Hygiene Assistance:** Providing basic hygiene products to those in need, on supervision.

**Mental Health Court:** A Court supervised intensive individualized case management, in a non-adversarial manner, serving participants with co-occurring disorders. The program provides professional mental health support through community treatment providers.

**Offenders Offering Alternatives:** Participants have an opportunity to spend a day in a correctional facility, which is led by incarcerated offenders. The program allows participants a glimpse of the realities of institutional incarceration, as a deterrent to continued criminal behavior.

**Pathways to Change:** A 12 week cognitive restructuring program, promoting positive change.

**Veterans Court:** An Intensive Supervision Court, tailored to meet the individual needs of Veterans with substance abuse, mental health, and trauma.

**Victim Impact Panel:** Designed to provide participants to becoming aware of how their crime personally affects their victims and family.
