

## DISTRICT PROGRAMS

**Intake:** Orientation program for individuals newly placed on probation or parole supervision. The conditions of supervision are reviewed as well as information that can help you successfully complete your probation or parole.

### **Family & Friends Information Class:**

Orientation for the family and friends of offenders that are soon to be released from prison. The conditions of supervision are reviewed and resource information is provided.

### **Offenders Offering Alternatives (Prison**

**Tour):** The inmates at NECC and WERDCC sponsor this program for at risk first-time offenders. This includes inmate presentations, institutional tours, and one-on-one interaction with inmates.

**Pathways to Change:** A cognitive program to help offenders make positive choices and changes.

**Treatment Court:** An intensive approach to working with offenders who have substance abuse problems. The offender works with a team of specialists while learning to make positive decisions.

**Women's Support Group (Ladies Night):** A support group for female offenders. A variety of life skills and topics are covered.
