Treatment Court Unit

This unit is a Court-supervised treatment program for non-violent Adult Felony clients. The Treatment Court offers two core dockets consisting of Drug Court and a Veterans Court.

Felony Redirect Program

This program is a Post-Plea Deferred Sentencing diversion program for clients with little or no criminal history who are charged with a non-violent felony offense(s) and not suffering from substance use disorder.

Investigations Unit

This unit conducts comprehensive Sentencing Assessment Reports and Community Corrections Screenings on clients to assist the Court in sentencing. In addition, this unit completes Board and Field Information Replies summarizing offenses at the request of Probation & Parole Central Office and DOC institutions.
